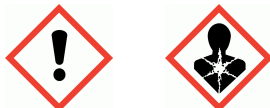

## SECTION 4: First aid measures

### 4.1. Description of first aid measures

## SECTION 5: Firefighting measures

### 5.1. Extinguishing media

### Methods for cleaning up

Large Spillages: If leakage cannot be stopped, evacuate area. Flush spilled material into an effluent treatment plant, or proceed as follows. <b>Appropriate engineering controls</b>	Provide adequate ventilation.
